KNOW ALL PERSONS BY THESE PRESENTS:

as PRINCIPAL, and \_\_\_\_\_ a corporation organized under the laws of \_\_\_\_\_ and authorized to transact a general surety business in the State of California, as SURETY, are held and firmly bound to the People of the State of California in the penal sum of fifty thousand dollars (\$50,000.00), for which payment we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents.

WHEREAS, the provisions of Vehicle Code Section 1810.2(c) require that the Principal file or have on file with the Department of Motor Vehicles a bond in the sum of \$50,000.00, and this bond is executed and tendered in accordance therewith.

NOW, THEREFORE, the conditions of the foregoing bond are that if the Principal shall:

- (1) Hold the Department harmless from any monetary loss to the Department by reason of the Principal's use of information obtained from the Department; and
- (2) Pay to the Department any and all sums due the Department for application fees and for information from Department records provided by the Department to the Principal; and
- (3) Pay to the Department, its officers, and any other person(s) all civil damages occasioned to the Department or such persons by reason of the following acts or omissions by the Principal, its representative or agent, or by any person to whom the Principal sells, gives, or otherwise furnishes information received by the Principal from the Department:
  - (a) Obtaining information from the Department by means of false or misleading representations,
  - (b) Using information obtained from the Department for any purpose different from the purpose specified in the Principal's application for a Commercial Requester Account, and
  - (c) Selling, giving, or otherwise furnishing any information obtained from Department records to any third party not specifically authorized and approved by the Department, then, this obligation is to be void, otherwise it is to remain in full force and effect.

PROVIDED, HOWEVER, this bond is issued subject to the following express conditions:

- (1) This bond shall be deemed continuous in form and shall remain in full force and effect and shall run concurrently with the period for which the commercial requester account is granted and each and every succeeding period or periods for which said Principal may have renewed the commercial requester account, after which liability hereunder shall cease except as to any liability or indebtedness therefore incurred or accrued hereunder.

- (2) This bond is executed by the Surety to comply with the provisions of Vehicle Code Section 1018.2 and of Chapter 2, Title 14, Part 2 of the Code of Civil Procedure and said bond shall be subject to all of the terms and provisions thereof.
- (3) The aggregate liability of the Surety hereunder on all claims whatsoever shall not exceed the penal sum of this bond in any event.
- (4) This bond may be cancelled by the Surety in accordance with the provisions of Sections 996.310 et seq. of the Code of Civil Procedure.
