(1) If the Principal shall well and truly comply with all of the requirements of Municipal Code Section J103.7.5 & J103.7.6 and with all of the applicable provisions of Title 15, Chapter 15.04 of said Code, and (2) If all work required to be done complies with all of the terms and conditions of the Permit for excavation or fill to the satisfaction of the Building and Safety Division and completed within the time specified in the Grading Permit, then this obligations shall void; otherwise it shall remain in full force and effect.

It is understood that the liability of the principal and surety upon this bond is a continuing obligation and shall be in effect from the date hereof until the completion, to the satisfaction of the Building and Safety Division of all the terms and conditions of said Grading Permit, or in the event of a change in ownership prior to the completion of the grading and the new owner selects to secure a new permit and post a new bond for the completion of the grading work, than this obligation shall be void; otherwise to remain in full force and effect.

It is further understood that the time limit specified in the permit above mentioned, may be extended for good and sufficient cause by the Building and Safety Division Manager. No such extension of time shall be valid unless the same be in writing and no such extension of time shall release the principal or surety from the obligation of this bond.
