We, the Surety, who are authorized to transact business as a Surety in the State of Montana, and the above Principal, are firmly bound and indebted to the State of Montana in the sum of the above amount of bond for which payment we bond ourselves and legal representatives and successors, jointly and severally.

This bond is being executed because the principal has applied to the Montana Department of Transportation for a license to engage in business as a Gasoline/Special Fuel Distributor pursuant to the Montana Gasoline and Special Fuels License Tax Laws, Title 15, Chapter 70, MCA.

This bond is intended to comply with the requirements of the Gasoline and Special Fuel License Tax Laws, and it is expressly provided that:

- 1. The Principal shall at all times keep this bond in full force and effect and, upon any cancellation or revocation of this bond or withdrawal of the Surety, shall cease business as a Gasoline and Special Fuel Distributor until such time a new bond is filed and approved by the Montana Department of Transportation.
2. The Surety shall be liable for any failure of the Principal to comply with Gasoline and Special Fuel Licensing Tax including, but not limited to, any tax, interest, and/or penalty, which is due from the Principal up to the limit. This bond does not limit the liability of the Principal under the Gasoline and Special Fuel License Tax Laws.
3. This bond shall be deemed continuous in form and shall remain in full force and effect unless terminated or canceled in the manner hereinafter provided in this agreement.
4. The Montana Department of Transportation, through its authorized agents, reserves the right at any time to require a new bond or bond of greater amount than this bond or to require another Surety or Sureties be provided whenever the Department or its agents deem it necessary to comply with the provisions of the Gasoline and Special Fuel License Tax Laws.
5. The Surety may cancel this bond and be relieved of further liability under this bond by giving 30 days written notice to the Administration Division of the Department of Transportation at the above address. This cancellation shall not affect any liability incurred by the Surety or Principal prior to the termination of the notice period.
